Who can sign this form?

Companies – Where the company has a sole Director who is also the sole Company Secretary, this form must be signed and dated by that person. If the company (pursuant to section 204A of the *Corporations Act 2001*) does not have a Company Secretary, a sole Director can sign and date alone.

If the company has more than one Director, this form must be signed and dated by two Directors or by one Director and the Company Secretary.

Joint holders – If the concession is in more than one name (partnership or otherwise), all holders must sign and date this form. If there are more than two holders, please attach a separate sheet.

Power of Attorney or Authorities – To sign under a Power of Attorney or Authority you must produce an original certified copy of the Power of Attorney or Authority to this form.

Trusts – SFRs – AFMA does not accept Trusts, Incorporated Trusts or Superannuation Funds however, the Trustee, as either an individual or company, can sign and date this form. AFMA will not accept a Trustee of a bankrupt estate.
