#### Who can sign this form?

**Trading Names** – All individuals for corporate owners of a trading name must be specified as the applicants and all sign this form.

**Companies** – A company may sign in any manner (including under seal) authorised by s127 of the *Corporations Act 2001*. If a company has more than one Director this form may be signed and dated by two Directors. If a ciompany only has one Director, that Director may sign and date this form. A copy of the registered power should accompany this form.

**Trusts** – The beneficial interests in any trust will not be recognised by AFMA (see s47 *FM Act 1991*). A trustee may only sign and date this form as the legal owner in their own right.
