1 Preliminary business

1.1 Chairs opening remarks

The Northern Prawn Fishery Management Advisory Committee (NORMAC) Chair, John Glaister, opened the videoconference at 02.00 pm (AEDT) on 22 February 2021 with an Acknowledgement of Country. Apologies were noted from Industry Members Ron Earle and Gregory Albert.

1.2 Adoption of agenda

The agenda was adopted without change.

1.3 Declaration of interests

The Chair advised that NORMAC consider the standing table of declared interests (Attachment 2) and individually declare whether the stated interests are accurate, and if not, provide an update. Updated interests were declared by Arthur Raptis, noted by the MAC and updated in Attachment 2. It was also noted that all industry participants had a potential conflict regarding agenda item 2 – Broodstock, but their contribution to the discussion was considered essential. No other apparent conflicts of interest were identified that would prevent individuals participating in discussions.

1.4 Minutes from previous meeting

It was noted that the Minutes from the 01 October 2020 meeting were accepted out-of-session and are published on the AFMA website.

2 Broodstock

NORMAC noted that the NPF Resource Assessment Group (NPRAG) had discussed the results of the *Penaeus monodon* stock assessment project at its February 2021 meeting and provided advice/ recommendations on a sustainable approach for *P. monodon* catches in the NPF as follows:

- Maintain status quo for the management of *P. Monodon*, noting there is significant variability in the incidental catches of *P. Monodon* taken within the commercial fishery.
- This will allow the continuation (and improvement where possible) of current *P. Monodon* data collection and monitoring across the fishery (commercial byproduct and targeted broodstock collection).
- The existing management controls that are in place for the banana and tiger prawn fisheries (e.g. seasonal closures, gear restrictions) also provide protection to *P. monodon* populations.
- Undertake another stock assessment in 3 years (2024), which will include data up until 2023 (including broodstock collection discard data from 2017-2023).
- In the interim, commence annual monitoring of total catch (5-year running average) against the two estimates of MSY from the model to assess possible risk to stock sustainability. Total catch (including discard mortality) less than MSY is not likely to lead to overfishing.
- Based on the results of the model (noting there is significant uncertainty within the model) the RAG does not believe that the stock is currently overfished or overfishing is occurring. As with other Penaeus species, there is significant annual variability for these stocks due to environmental factors and therefore limit reference points (e.g. tiger prawns) are set based on the moving average of B_Y/B_{MSY} and other indicators to take account of this variability.
- While the RAG recommended the maintenance of current catch levels, it did not provide any recommendation on sustainable take between the commercial byproduct or targeted broodstock collection as this should be considered by NORMAC.
- NPRAG also noted that the peak period for broodstock demand is during June to August each year. Considering this, it was suggested that the total *P. monodon* catch could be reviewed after the banana prawn season, as the largest proportion of total *P. monodon* is caught during the start of the banana prawn season in the higher catch years. This could potentially allow the targeted broodstock fishing limit to be reviewed mid-year. It was cautioned, however, that targeted broodstock and *P. monodon* taken as commercial byproduct are caught in different areas and this should also be considered when reviewing any broodstock catch limits.

It was advised that, due to administrative oversight, the NPRAG Chair's appointment had expired prior to the February NPRAG meeting. NORMAC noted the NPRAG Chair was not formally appointed while providing NPRAG's recommendation on a sustainable approach for *P. monodon* catches in the NPF. The MAC acknowledged this in considering NPRAG's advice.

The demand for broodstock from the NPF was discussed and the MAC noted that since 2019 when 20,000 individuals were requested orders from farms have remained within the supply cap. During 2020, a number of available broodstock trips were not taken up and the total number of individuals ordered was within the 9,000 supply limit. Reasons for the lower demand were attributed to some operators collecting their own broodstock by fishing under NPF statutory fishing rights (SFRs) and some hatcheries having a greater level of operational success from broodstock than previous years. Preliminary estimates indicate the demand for broodstock in 2021 will again be within 9,000 individuals. It was noted that the 9,000 animal supply limit is sufficient to meet current demand by the aquaculture industry.

It was noted that continuing to apply the 9,000 animal supply limit is unlikely to compromise the sustainability of *P. monodon* in the NPF, however, it was questioned whether the bycatch, and in particular sawfish, generated any broader sustainability concerns. As the number of sawfish caught during broodstock fishing has significantly decreased from the high volume in 2018, the level of concern and associated risk to bycatch species has reduced. It was noted that AFMA and NPRAG continue to monitor the broader risks from broodstock fishing and will continue to provide updates if there is any change to the risk status.

Limiting the number of individuals that can be caught using a broodstock permit was discussed as the majority of *P. monodon* is caught as commercial byproduct in the NPF. The MAC noted that the 9,000 individual broodstock supply limit is part of the current management arrangements for the *P. monodon* stock and the results of the stock assessment demonstrate there is no immediate concern with catch volumes across the fishery. Considering this, and the fact that the 9,000 supply limit is sufficient to meet current aquaculture demand, the MAC supported maintaining the current supply limit for broodstock at 9,000 individuals.

NORMAC accepted the broad NPRAG advice from its February meeting and recommended to retain the status quo of the current management arrangements with enhanced monitoring arrangements for *P. monodon*, noting:

- the significant fluctuations in commercial byproduct catches (similar to the other penaeid species taken in the fishery) from several hundred kilos to around 8 tonnes;
- continuing to apply the 9,000 animal supply limit is unlikely to compromise the sustainability of *P. monodon* in the NPF; and
- the 9,000 animal supply limit is sufficient to meet current demand by the aquaculture industry.

3 Remake of NPF Directions

NORMAC noted that the four NPF Directions are being remade and was asked to comment on the proposed changes. No comments were provided and NORMAC supported the proposed Directions as presented.

4 Other business

No other items of business were included in the agenda.

5 Next meeting

The Chair advised the next meeting is scheduled for May 2021 and ended the meeting at 3.20 pm.
